### **RULES AND REGULATIONS FOR WADSWORTH SKATE PARK**

- This Park shall operate under the provisions of Section 316.0085, Florida Statutes.
- Anyone under the age of 17 must obtain written consent from a Parent or Legal Guardian as provided on the Consent/Release Form in his/her own name.
- City issued photo I.D. is required to use this Skate Park facility or temporary ID Card.

**While engaged in skateboarding or inline skating, participants are responsible for doing all of the following:**

- All participants shall act within the limits of his or her ability and the purpose and design of the equipment used.
- No participant shall utilize the facility while sick or injured.
- All participants shall maintain control of his or her person and the equipment used.
- All participants shall refrain from acting in any manner which may cause or contribute to death or injury of himself/herself or other persons.
- This facility is designated for skateboarding or rollerblading only (**NO BICYCLES OR SCOOTERS**).
- No alcohol, drugs or tobacco products are allowed.
- No weapons of any kind are allowed.
- School attendance mandatory for use of this Park.
- It is your responsibility to keep this facility clean.
- **HELMETS ARE MANDATORY.**
- The City of Flagler Beach and Flagler County recommend that protective gear and clothing be worn and that children be accompanied by an adult.

### **MANAGEMENT AND MAINTENANCE**

The Skate Park was constructed and is being maintained by Flagler County; the Skate Park is operated and managed by the City of Flagler Beach.
